



# Privacy Policy

This Privacy Policy explains how Nvestiv Inc. and its subsidiaries and affiliates (collectively, “Nvestiv”, “we”, “our” and “us”) collects, uses, shares and protects information obtained from members and from visitors to its website, [www.nvestiv.com](http://www.nvestiv.com) (the “Site”) and the services, features, content, platform, tools or applications we offer, including through our platform or any mobile or web app (collectively with the Site, the “Services”). If you are a member with access to Nvestiv’s Services, you have agreed and are additionally subject to the “TOS”, which incorporates this Privacy Policy by reference. By visiting the Site or using the Services, you consent to the collection, disclosure and use of your information under the terms of this Privacy Policy.

## 1. Purpose

When you share information with us, we can make our Services even better by showing you more relevant information and connecting you with others more quickly and easily. As you continue to use our Services, we want you to clearly understand how we are using your information and how you can protect your privacy. Furthermore, all information collected from the use of the platform by any user is private and is explicitly required to be kept in confidence from all third parties.

**This Privacy Policy is designed to clarify:**

1. What information we collect and why we collect
2. How we use that information.
3. And the choices you have to access, share and update information.

## 2. Scope of Information

We collect information in several ways, including:

### **Information you submit to us**

When you sign up for our Services and an account is created (your “Account”), we will ask for personal information, including but not limited to your name, email address or telephone number, which may be personally identifiable information (“Personal Information”). If you want to take full advantage of the Services, you’ll also need to create a profile that will be a part of the

information submitted to us. By creating an Account on the Services and providing such Personal Information to us, you allow others, including us, to identify you and therefore may not be anonymous. All content submitted by you to the Services may be retained by us indefinitely, even after you terminate your Account. We may continue to disclose such content to third parties in a manner that does not reveal Personal Information, as described in this Privacy Policy.

### **Information we get from your use of our Services**

We may collect information about the Services that you use and how you use them, like when you visit a certain part of our Site and how you interact with our content. This information includes:

#### **Device information**

We may collect device-specific information (such as your hardware model, operating system version, unique device identifiers, and mobile network information including phone number). Nvestiv may associate your device identifiers or phone number with your Account.

#### **Log information**

When you use our Services or view content provided by us, we may automatically collect and store certain information in server logs. This may include:

Details of how you used our Services, such as your search queries.

Internet protocol address.

Device event information such as crashes, system activity, hardware settings, browser type, browser language, the date and time of your request and referral URL.

Cookies that may uniquely identify your browser or your Nvestiv Account.

Usage information, such as the number and frequency of visitors to the Site.

#### **Cookies and anonymous identifiers**

We use various technologies to collect and store information when you use our Services, and this may include sending one or more cookies or anonymous identifiers to your device or browser. You can configure your browser to accept all cookies, reject all cookies, or notify you when a cookie is set. However, we strongly recommend that you leave cookies active, because they enable you to take advantage the most attractive features of the Services. This Privacy Policy covers our use of cookies only and does not cover the use of cookies by third parties. We do not control when or how third parties place cookies on your computer.

#### **Email communications**

We may receive a confirmation when you open an email from us. We use this confirmation to improve our customer service.

#### **Aggregate information**

We collect statistical information about how both members and visitors, collectively, use the Services (“Aggregate Information”). Some of this information is derived from your Personal Information, but this statistical information is not Personal Information and cannot be tied back to you, your Account or your web browser.

#### **Financial information**

Financial information, such as your payment method (valid credit card number, type, expiration date or other financial information) may be collected and stored by a third-party payment processing company (the “Payment Processor”) and use and storage of that information is governed by such Payment Processor’s applicable terms of service and Privacy Policy.

### **3. Use of Information**

We use the information we collect to provide, maintain, protect and improve our Services, to develop new ones, and to protect Nvestiv and our users.

We use your Personal Information to process and administer details of your membership, to communicate with you, to provide you with opportunities, and to keep you up to date with new developments at Nvestiv.

We also use and analyze the information we collect so that we can administer, support, improve and develop our business. Nvestiv may contact you using information you voluntarily provide. It’s important for you to understand that:

Except as set forth herein, we do not share your information with unaffiliated companies for marketing purposes without your prior permission.

Unless you opt-out, we may share information about you among companies affiliated with us to inform you about additional products, services or promotions that may be of interest to you.

If you contact us for troubleshooting, we may also keep a record of that fact to better serve you and other Nvestiv customers in the future.

### **4. Disclosure of Information**

1. *Disclosure for our protection or our users’ protection.* Nvestiv is committed to keeping your information confidential. Nvestiv may access, preserve and disclose your Personal Information:
2. in response to legal process.
3. to protect our rights, as otherwise required by law or permitted by this Privacy Policy and the Terms of Service, including investigations of potential violations hereof; or

4. in response to user support requests or for the prevention or detection of a crime.
5. *Business transfers.* If we sell our company or any part of it, or our business enters into a joint venture with another business entity, Nvestiv may disclose or transfer your Personal Information to our new business partners or owners who may then provide you with information about their products and services. You acknowledge that such transfers may occur, and that any acquirer of us or our assets may continue to use your Personal Information as set forth in this policy.
6. *Third party disclosures.* Nvestiv does not sell, license, lease or otherwise disclose your information to any third party except as set forth in this policy and as described below:
  7. In order to administer or process a transaction, product or the services provided by Nvestiv.
  8. To comply with applicable laws, regulation or legal process.
  9. To detect, prevent or otherwise address fraud or security issues.
10. We provide information to our agents, affiliates or other trusted businesses or persons to process it for us, based on our instructions and in compliance with our Privacy Policy and any other appropriate confidentiality and security measures; and
11. To help us improve our services to you, we may engage another business to help us to carry out certain internal functions such as account processing, fulfillment, member service, member satisfaction surveys or other data collection activities relevant to our business.
12. We share Aggregate Information with our partners, service providers and other persons with whom we conduct business. We share this type of statistical data so that our partners can understand how and how often people use our Services and their services or websites, which facilitates improving both their services and how our Services interface with them. In addition, these third parties may share with us non-private, aggregated or otherwise non-Personal Information about you that they have independently developed or acquired.
13. As stated above, a Payment Processor may collect and store financial information. We may, from time to time, request and receive some of your financial information for the purposes of completing transactions you have initiated through the Services, enrolling you in discount, rebate, and other programs in which you elect to participate, protecting against or identifying possible fraudulent transactions, and otherwise as needed to manage our business.
14. When you use the Platform, if you connect with an entity that is seeking an investment (“Target”): (i) prior to connecting, you will be able to see the Target’s deal flow, historic performance, and other basic financial information. You will not be able to see the Target’s name; and (ii) after you match with a Target, in addition to the previous information, you will be able to see the Target’s name, phone number, email address, mailing address, and other basic contact information to allow you to contact the Target. If you are a Target, you consent to the disclosure of this information to investors on the Platform.
15. When you use the Platform, if you connect with an investor: (i) prior to connecting, you will be able to see the investor’s past investments, specific objectives, and other information about their investment history and desired future investments. You will not be able to see their name or identity; and (ii) after you match with an investor, in addition to the previous information, you will be able to see the investor’s name, phone number, email address, and other basic contact information to allow you to contact the investor. If you are an investor, you consent to the disclosure of this information to users of the Platform, which may include placement agents, fund managers, and Targets.

## 5. Limits on Google User Data

Notwithstanding anything else in this Privacy Policy, if you provide us through the Services with access to the following types of your Google data, our use of that data will be subject to these additional restrictions:

Nvestiv Services will only use access to read, write, modify, or control Gmail message bodies (including attachments), metadata, headers, and settings to provide a web email client that allows users to compose, send, read, and process emails and will not transfer this Gmail data to others unless doing so is necessary to provide and improve these features, comply with applicable law, or as part of a merger, acquisition, or sale of assets.

Nvestiv Services will not use this Gmail data for serving advertisements.

Nvestiv Services will not allow humans to read this data unless we have your affirmative agreement for specific messages, doing so is necessary for security purposes such as investigating abuse, to comply with applicable law, or for our internal operations and even then, only when the data have been aggregated and anonymized.

## 6. Disclosure of Involvement and Public Evaluations

Nvestiv does not disclose the identities of any members on the platform for reasons such as references, advertising, etc. unless for the purpose of matchmaking and working towards a capital introduction. All users of the platform are subject to also prohibited from disclosing their involvement with us unless provided with written permission to do so by us.

Nvestiv will not evaluate any user of the platform based on information collected on them or their involvement with the platform on any publicly available forum or medium. All users of the platform are prohibited from publicly evaluating or reviewing Nvestiv on any publicly available forum or medium such as tweets, social media posts, blog posts, articles, websites, videos, etc. without the express written consent of Nvestiv.

## 7. Security & Information Retention

We employ security measures to protect your Personal Information both online and offline from access by unauthorized persons and against unlawful processing, accidental loss, destruction and damage. We encrypt many of our services using SSL. We will retain your Personal Information for a reasonable period or as long as the law requires. If you cease to be a member of Nvestiv, we may retain your Personal Information for our business purposes provided that we would protect all such information about you in accordance with this Privacy Policy.

## 8. Sharing Risk

We cannot guarantee that only authorized persons will view your personal information. We cannot ensure that information you share on our website will not become publicly available.

We are not responsible for third party circumvention of any privacy settings or security measures on our website.

You can reduce these risks by using common sense security practices such as choosing a strong password for your email account and using up to date antivirus software.

We do not disclose the identities of users or disclose our involvement with users for purposes such as advertising, references, or listing transactions. All users are subject to the same requirement to not disclose

## 9. Third Party Sites

We are not responsible for the practices, privacy policies or the content of third-party sites, services and applications (“Third Party Services”) we link to or you elect to access through the Services and have no control of the use or protection of information provided by you to or collected by those Third-Party Services. Whenever you choose to access a Third-Party Service, you may be asked to provide registration or other information. Please note that the information you are providing is going to a third-party, and you should familiarize yourself with the Privacy Policy provided by that party.

## 10. Accessing Information

If you are a member, you can access information associated with your Account by logging into the Services. Members and visitors can access and delete cookies through their web browser settings.

## 11. Account Closure

Should you ever decide to delete your Account, you may do so by emailing [info@nvestiv.com](mailto:info@nvestiv.com). If you terminate your Account, any association between your Account and information we store will no longer be accessible through your Account.

## 12. Changes to This Policy

Nvestiv may update this policy from time to time. Any changes to this Privacy Policy in the future will be indicated on the Site. Your continued use of the Site and, if you are a member, your continued participation in Nvestiv, will indicate your agreement to such changes.
